

City of Mesquite/Keep Mesquite Beautiful, Inc. KMB Proud Business Program Guidelines

Objectives: To prevent littering in business areas through cleanup efforts;
To encourage community ownership of business areas;
To educate businesses about the problem of litter and that a clean business deters crime; and
To encourage partnership efforts between the City of Mesquite, Keep Mesquite Beautiful and the Mesquite business community.

Guidelines:

- ◆ Only Mesquite businesses who receive appropriate training through Keep Mesquite Beautiful, Inc. will be permitted to participate.
- ◆ Participating groups must agree to hold a cleanup on their property monthly.
- ◆ Participating groups will be responsible for reporting scheduled cleanups to the Keep Mesquite Beautiful Executive Director, as well as the results of such cleanups (how many people, how much trash picked up, etc.) on the attached Reporting Form.
- ◆ Each participant must sign the Hold Harmless Agreement.
- ◆ Each group shall be responsible for furnishing adequate supervision by one or more adults for participants of a group who are fifteen (15) years of age or younger.
- ◆ Each group shall be responsible for maintaining a first-aid kit and adequate drinking water while participating in litter pickup at their business. If you do not have a first-aid kit readily available, KMB will furnish a first-aid kit.
- ◆ Each group shall be responsible for obeying and abiding by all applicable local, state and federal laws and regulations while participating in cleanup events through the KMB Proud Business Program.
- ◆ Participating groups will receive a KMB Proud Business sticker which will be posted at visible location.
- ◆ Participating groups will also receive recognition in the *Mainstream* newsletter upon joining the KMB Proud Business Program.

Training

Keep Mesquite Beautiful, Inc. will provide training for participating organizations on safety, proper litter handling methods, items and materials to avoid, when to organize cleanups, etc. One training session will be held with the participating group prior to beginning cleanups. Scheduling and Reporting of Cleanups

Cleanups through the KMB Proud Business Program will need to be scheduled in order to maintain accurate records and guarantee pick-up of trash bags. One member of the participating group will be given the responsibility of scheduling cleanups with the Keep Mesquite Beautiful Executive Director. This individual will schedule cleanups at least two (2) weeks prior to the date of a proposed cleanup. The Keep Mesquite Beautiful Executive Director will arrange pick-up of trash bags with the Sanitation Division.
