BLAST Camp Rules and Discipline Policy

To: Parents and Participants:

Please discuss the following code of conduct with your child(ren), sign and return this form with your registration packet. In fairness to all participants and staff of the BLAST Camp program, we expect appropriate behavior. Disciplinary action will be taken when necessary. In order to ensure a safe and enjoyable time in the BLAST Camp, the following rules have been established.

- All participants must meet at their designated point each day.
- All participant parents/guardians must sign in each day.
- All parents/guardians or designated person picking up a participant must sign the participant out each day.
- All participants will stay with their assigned group in their assigned area.
- Participants must have permission to go to the restroom or leave the presence of the Recreation Leaders (The buddy system will be enforced).
- Participants must obey leaders and rules at all times. Disrespect will not be tolerated.
- Participants will respect the camps/recreation center’s property and play with all equipment safely.
- Participants will not swear, call names, or fight (If someone says or does anything that hurts you or your feelings, inform a staff member)
- Drinks and food will only be permitted at designated times and places.

Discipline Policy and Consequences

General Provisions

Children must be respectful of instructors and property at all times. Improper use of furniture, drink, food, misuse of equipment, horseplay or vulgar/abusive language will not be permitted.

- 1st offense - On spot counseling and time out from activities
- 2nd offense - Suspend from program for 1 to 3 days depending on severity of the incident and circumstances
- 3rd offense- Suspension for 1 week from program activities and from the City of Mesquite Recreation Centers depending on the severity of the incident and circumstances

Fighting

- 1st offense - Suspension 1 to 3 days
- 2nd offense - Suspension for 1 week
- 3rd offense - Removal from the program and from the City of Mesquite Recreation Centers

Parents and Participants

All suspensions depend on the severity of the incident and circumstances. When a participant is suspended from the program they are also suspended from the City of Mesquite Recreation Centers.

Parents will not be refunded for the time their child(ren) is suspended from the program whether it is for one day or one month. Your help in reviewing the rules and guidelines with your child(ren) will be very helpful and appreciated.

If BLAST Camp rule are violated, one or more of the disciplinary actions (as defined in the above Discipline Policy and Consequences) may be imposed for violations of the above rules.

Attention Parents and Guardians,

The BLAST Camp and all the other camp recreation programs offered by the City of Mesquite must be defined and/or clarified as recreational programs and are not to be considered as “child-care” programs.

The City of Mesquite and all other Texas municipalities are eligible to be exempt from State day-care licensing provided a Standards of Care ordinance is approved annually. In Mesquite, a Standards of Care ordinance is in place, which allows the Parks and Recreation Department to offer a wide variety of recreation programs that have become extremely popular at our recreation centers. Our Standards of care will be made available to you.

The City of Mesquite is not licensed by the State to provide child care programs.
