## YOUTH VOLLEYBALL LEAGUE

For girls ages 7-14, this recreational volleyball league is a combination of teams that are hand-selected by a coach and teams that are formed through a "draft" system by zip code. All hand-selected teams must be registered by the coach and players requesting a specific coach or team will be added at the coaches discretion. Teams will play seven league games and participate in a single elimination, end of season tournament. Games will be played on Monday nights and teams will have a minimum of one practice per week.
