GENERAL INFORMATION

1. All reservation fees must be paid through the PARD office located at 1515 N. Galloway, 972-216-6260 at the time the reservation is made. Reservation fees will not be accepted at the pools.
2. Reservations must be booked and paid for at least one week (7 days) prior to the event.
3. Proof of residency is required during the payment process.
4. Every person entering the pool facility for reservations will count toward occupancy levels, including those individuals that do not intend to swim.
5. Reservations will be accepted from adults only. For youth groups, adult chaperones shall be in ratio of three (3) adults for groups of twenty-five (25) children.
6. City personnel will be present to open and close the pool and provide lifeguard services.
7. Pool rules and regulations, which apply to the general public, must be observed during reservations.
8. Groups making reservations are prohibited from charging admission, collecting or raising funds.
9. Prior approval must be granted from the PARD if decorations are planned.
10. Sound equipment may be permitted, provided that it is not disturbing to other patrons or residents.
11. For swimming pools 50% of the reservation fee will be assessed for any cancellations less than one week (7 days) from the scheduled date of the reservation. 25% of the reservation fee will be assessed for any cancellations more than one week (7 days) from the scheduled date of the reservation. A \$25.00 fee will be assessed for any changes after the reservation is set.
12. Pool reservations begin at 7:30 p.m. Entry before 7:30 p.m. is NOT permitted.
