Notice of Executive Session – Consultation with Attorney

Pursuant to Section 551.071, of the Texas Government Code, the City Council may meet in closed session to conduct a private consultation with its attorney related to pending or contemplated litigation, a settlement offer, and/or a matter in which there exists a duty of the City Attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas that conflicts with the Texas Government Code Chapter 551.

Following discussions in executive session, the City Council will reconvene in open session where any final action regarding executive session items will be taken.
