Appointment of a three-member board composed of a physician, a psychiatrist, and a psychologist, or any combination, as appropriate, pursuant to Section .081(c) of Commission's Rules and Regulations (the "Local Rules") and Section 143.081(d) of the Texas Local Government Code, to examine Mesquite Police Officer Heath Ewing ("Officer Ewing"), and make findings as to Officer Ewing's physical and mental fitness for duty and authorizing the Director of the Commission to schedule, arrange, pay for, and take all other actions necessary to facilitate such examinations.
4. Approval of the City of Mesquite Fire Department 2018 seniority list.
5. Approval of the City of Mesquite Police Department 2018 seniority list.
6. Adjournment.


Pursuant to Section 551.074 of the Texas Government Code, the Commission may deliberate the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee in a closed executive session unless the officer or employee who is the subject of the deliberation or hearing requests a public hearing.

Pursuant to Section 551.071 of the Texas Government Code, a closed executive session may be held if the discussion of any of the above Agenda items concerns a matter in which the duty of the attorney to the City of Mesquite Fire Fighters' and Police Officers' Civil Service Commission under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Texas Government Code.

Following discussion in closed executive session, the members of the City of Mesquite Fire Fighters' and Police Officers' Civil Service Commission will reconvene in open session where any final action regarding closed executive session items will be taken.
