In accordance with the Governor's suspension of various provisions of the Texas Open Meetings Act issued pursuant to his State Disaster Authority, and guidance issued on the suspension by the Attorney General's Office:

1. A quorum of the Commission will participate in the meeting by videoconference or by being physically present at the meeting location.
2. Training Rooms A & B located at 757 North Galloway Avenue, 2nd Floor, Mesquite, Texas, ("meeting location") will not be open to the public.
3. Applicants having matters on the agenda and interested parties may participate by appearing at the meeting location or by videoconference.
4. Members of the public may participate by videoconference.
5. Those participating by videoconference may do so as follows:

6. Those present at the meeting location must observe social distancing by remaining a minimum of six (6) feet from other meeting participants and wearing a mask covering the nose and mouth.
