Free summer food program

Thanks to the Summer Food Service Program, children in Mesquite will be able to enjoy free nutritious meals throughout the summer. The Mesquite Independent School District (MISD) will serve free breakfast and free lunch within the community through a program that is provided by the Texas Department of Agriculture. No advance qualifying or registration is required. This program is open to all children 1 - 18 regardless of race, color, national origin, sex, age or disability, and there will be no discrimination in the course of the meal service. Rules for Summer Nutrition Program

- Parents who choose to eat with their children may purchase breakfast for \$1.50 and lunch for \$3.00.
- Parents are not allowed to eat from the child's meal at any time.
- Due to health and sanitary rules, all the meals must be eaten in the school cafeteria. No part of the meal may be taken away from the cafeteria.
- This program is funded by the Texas Department of Agriculture and their rules must be followed at all times.

Police Department safety tips

The Mesquite Police Department (MPD) wants everyone to have a good time and partake in the Independence Day festivities, but they also want residents to remain safe. During the month surrounding July 4th, a national average of 200 people visit the emergency room each day as a result of fireworks-related injuries. Surprisingly, 12 percent of all fireworks-related injuries are caused by sparklers. MPD would like to remind residents that it is illegal to use fireworks and to discharge a firearm (even in the air as part of a celebration) within the city limits.

- Clean up after your pet
- Keep your pet up-to-date on vaccinations and register them with the City
- Keep current vaccination and identification tags on your pet
