Officer-Involved Shooting Investigation

On Tuesday, May 4 at 7:45 am, the Mesquite Police Department received a 911 hang-up call, where a female could be heard screaming and crying in the background. MPD dispatch was able to locate the address based on a prior call from the same phone number. In response to this call, officers were dispatched to the 5800 block of Northwest Dr., the Audubon Park Apartments.

Upon arrival at the location, officers made their way to the apartment where they were contacted by the victim, who advised that the suspect was armed with a knife. Officers made contact with the suspect on the side of the apartment building where the suspect charged at officers, armed with a knife and a club. At this time, two officers discharged their duty weapons at the suspect, striking him. Officers rendered first aid to the suspect until medical personnel arrived on the scene. The suspect was transported to a local hospital, where he was later pronounced deceased. A second ambulance was requested by officers for an assault victim at the location.

The suspect has been identified as Ashton Pinke, a 27-year-old male from Dallas, Texas.

The officers are identified as a 25-year veteran officer (female) and a 21-year veteran officer (male). No officers were injured during this incident.

As per departmental policy, the involved officers have been placed on administrative leave with pay.

Per protocol, Investigators with the Dallas County District Attorney's Office responded to the location.

This is an ongoing investigation and more details will be released as they become available. Body Worn Camera Footage of this incident is being reviewed at this time and will be released to the public later this week.

The male stuck his head out the 2nd story window and stated he did nothing wrong and was not coming outside. He stated his name was Chris Proctor. Research on the apartment showed a possible suspect of Ashton Pinke, B/M 06-21-93. Officer looked at mugshots of the Ashton and confirmed that was him. He also had a matching tattoo, "loyalty", listed which was observed on his chest.

Ashton eventually came outside and placed into custody without any force being used. A computer check showed he had possible warrants out the Dallas Police Department. The warrants were confirmed. Ashton was also charged with Evading Detention and Fail to ID Fugitive/False Info. Officer transported and booked Ashton into the Mesquite Police Department without incident.
